Questions and Answers - Series 2

Q1. Concerning Mandatory Requirement "M1 – The proposed resource must be a Project Management Professional (PMP) with a valid certification."

Would an advisor who has completed a number of project management frameworks meet this mandatory requirement? (E.g., Macroscope by DMR, a methodology guide used by a great many businesses and governmental organizations).

- A1. You must be a certified Project Management Professional.
- **Q2.** Concerning Mandatory Requirement "M2 The proposed resource must have a minimum of one (1) year experience in facilitating a project management fundamentals course within the last three (3) years."

We are able to provide a senior advisor who carries out project management mandates, alternating them with small project-management-training mandates. This person is able to cover the fundamentals of project management and share his practical experience with participants. His practical experience extends far beyond fundamentals and theory, but he does not have the equivalent of one year of experience providing training and facilitating workshops on project management within the last three years. Would it be possible to withdraw the requirement that the experience be acquired within the last three years?

- **Q3.** In reference to M2 The proposed resource must have a minimum of one (1) year experience in facilitating a project management fundamentals course within the last three (3) years."

It may be difficult to find instructors with 1 full year experience in teaching the same course especially if it is a 2 or 3 day course. Would you consider revising M2?

ANNEX C: TECHNICAL EVALUATION CRITERIA

1. Overview

- a. The statements and requirements in this overview apply to the Mandatories.
- b. To demonstrate the experience of the Bidder or its personnel (i.e. resources), the Bidder must provide complete course details as to where, when (month and year) and how (through which activities/responsibilities) the stated qualifications/experience were obtained.
- c. Phrases such as "within the past five (5) years" used in this solicitation mean "within the five (5) years preceding the closing date of the RFP". In the event that the RFP closing date is changed after the initial publication of the RFP, the Bidder may choose to interpret the phrase as being measured from either the initial closing date or the final closing date, unless otherwise directed in an RFP amendment.
- d. The Bidder is requested to utilize the unique item number and associated title/description of each evaluation criterion in their responses.

2. Mandatory Criteria

The Bidder must provide a response to the mandatory requirements and should use the table format below. Note: Simply repeating the statement contained in the bid solicitation is not sufficient. The Bidder must respond to the corresponding mandatory requirements by providing a description explaining, demonstrating, substantiating and justifying their qualifications or approach to meet the requirement. Bidders are requested to provide a response to the mandatory requirement or indicate where their mandatory requirement is met by entering the location (e.g section/volume number, page number, etc.) in the "Substantiation" column.
