Questions and Answers - Series 6

- Q1. What is the budget ceiling for this tender?
- A1. The budget has not been established.
- **Q2.** Though it is stated that this is a 2-day training workshop, somewhere in the RFP suggest "The period of the contract is from date of contract award for one (1) year period inclusive." Please clarify.
- **A2.** The period of the contract is for a one year period because the dates for 2-day training workshops have not been established but will be delivered within a year of contract award.
- **Q3.** Can this bid application be sent by post or it must be submitted in person?
- **A3.** Please refer to the Request for Proposal Part 2, Section 2.2 "Submission of Bids". The bids do not need to be submitted in person.
- **Q4.** Is there any specific template for technical bid preparation?
- **A4.** No.
- **Q5.** Do we need a budgetary breakdown of the financial proposal or just Annex B will suffice?
- A5. Annex "B" Basis of Payment should be completed.
- **Q6.** Page 15 of 25 (Item 6.15) Royal Canadian Mounted Police may cancel any course without penalty provided that the contractor is given a minimum of five (5) days written notice. In the event that a course is cancelled with less than five days' notice, RCMP shall pay a cancellation fee of 50% of the price of the course.

Would RCMP be open to modifying this cancellation period to a minimum of 10 business days which would allow for the respondent to potentially seek replacement work?

SOLICITATION REVISIONS

- 1) On page 15, article 6.15 Cancellation Training,
- DELETE: Royal Canadian Mounted Police may cancel any course without penalty provided that the contractor is given a minimum of five (5) days written notice. In the event that a course id cancelled with less than five days' notice, RCMP shall pay a cancellation fee of 50% of the price of the course.
- INSERT: Royal Canadian Mounted Police may cancel any course without penalty provided that the contractor is given a minimum of ten (10) business days written notice. In the event that a course is cancelled with less than ten business days' notice, RCMP shall pay a cancellation fee of 50% of the price of the course.

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED
