Q126	With reference to your latest modification No. 37 regarding Table 6 – Move Services, based on the revised figures for both the number of Transferees per Year and the Total Weight per Year for Canada, the average weight for Outgoing shipment from Canada is 4,653 kg and the average weight for Incoming shipment to Canada is 4,795.40 kg. These average weight figures are still different from the initial figures and not in line with the average outgoing and incoming weights for the other locations. We would expect the average weights leaving Canada to be in line with the average weight arriving into the other locations, and vice versa.
