### **QUESTION ET RÉPONSES**

- Q 1. Are the windows for this project are to be fiberglass or aluminum? Spec says aluminum, drawing says fiberglass
- R1. See attached addendum 1
- Q2. Project is calling for ceiling hung washroom partitions, however I don't see any structural reinforcing to allow for the partitions to be ceiling hung. Please clarify
- R2. See attached addendum 1
- Q3. The new service building has a metal roof on it and in the metal roofing spec section 07 61 00 item 2.1.1 indicates that the metal roofing profile and color is to match existing. I don't think there is any buildings around this new service building that has a metal roof to match. Can you please indicate a roofing profile and color that we would be able to use on the new construction?
- R3. See attached addendum 1
- Q4. Can you also please confirm that the wood siding is mandatory that it be western red cedar species?
- R4. See attached addendum 1
- Q5. On the Door & Frame Schedule on Drwg. A05, Doors # 101A, 102A & 103 are requesting Power Assisted Door Operators. These door operators are not specified in Section 08 71 10 Finish Hardware these power assisted door operators are not specified. Please confirm if power assisted door operators are required on this project. If they are, we would like to propose out Nabco GT-8500 Automatic Door Operators c/w [2] 4 ½" Square Wall Mounted Activation Switches per Operator. (see attached Product Literature)
- R5. See attached addendum 1

Q6. Section 10 28 12 Washroom Accessories is specifying paper towel dispensers and soap dispensers that are quite confusing. 2.2.2 Paper towel dispenser ( PTD ) is specifying two different items and the sizes do not make sense. 2.2.3 Soap dispenser ( SD ) seems to be asking for two different products and the size that is not consistent with the description.

R6. The specification identifies two acceptable products for each PTD and SD.
