The purpose of this amendment is to provide answers to questions received from industry, in Part 1, and to modify the RFP, in Part 2.

Part 1 – Questions & Answers

Question 7: Concerning Attachment 1 to Part 4 Customer References (below): We assume that with the statement ‘if requested by Canada’ references for all Corporate and Resources requirements are not required at time of bid and that they are only required upon request during the evaluation stage of the proposal. Please confirm our assumption is correct.

Answer 7: Bidders should provide references for all referenced projects with their proposal. However, in accordance with part d) *Customer Reference Contact Information* of section 3.2 *SECTION I: TECHNICAL BID*, Bidders “(...) must provide customer references (...) if requested by Canada (...)”. Failure to provide customer references if requested by Canada may render a proposal non-responsive. At its discretion, Canada may conduct reference checks on any given rated or mandatory requirement.

Question 8: Regarding criterion Part 3 – Bid Preparation Instructions, item 3.1, RFP page 10, Canada lists each individual Technical bid sections including Section IV – Additional information. Following this section on page 12 of the RFP, Section IV – Additional information and its detailed instructions are missing. Could the Canada please clarify if Section IV – Additional information is required and what information should be provided in the document.

Answer 8: Canada will remove *Section IV – Additional Information* for *Part 3 – Bid Preparation Instructions*. See *Part 2 – Changes to the RFP* of this amendment.

Question 9: Concerning the USB stick directions in Part 3 – Bid Preparation Instructions, RFP page 10, it states: “all soft copies should be submitted on one (1) USB stick”. We assume this is an error and that the Section II – Financial Proposal should be provided on a separate stick. Please confirm our assumption is correct.

Answer 9: Canada confirms that Bidders should provide all soft copies, including the financial proposal, on 1 USB stick.

Change 1

Under section 3.1 *BID PREPARATION INSTRUCTIONS*, delete:

(iv) Section IV: Additional Information (hard copy and 1 soft copy on a USB* key)
