Solicitation Amendment No. 001 is being issued to answer bidders' questions for solicitation W3827-18R3M3/A.

QUESTIONS AND ANSWERS

Q1) Will the orders be paced throughout or made all at once per year? Will this timing be coordinated with all locations or will each location's orders be independent of each other?

A1) The first order will be the main order to all current recruiters; and after the first order, it will be ordered as required basis on Active Posting Season (APS) transitions. The first order will be coordinated with all locations, subsequent orders will be independent of each other.

Q2) Where can I see samples?

A2) Clothing samples are included in Annex A. The rough example was developed based on general intent for a quality multi-use platform.

Q3) For the embroidery, is it possible to have a drawing with exact color requirements and size in order to have a better cost estimate from our supplier?

A3) On the recruiting emblem, sizes are 100% 5cmX7cm for the polo and the 110% 5.5cmX7.6cm for the fleece and jacket. We also require the same corresponding sizes for the "Forces Jobs" patch on the back as well. The font for the RECRUITING/RECRUTEMENT for the left sleeve is Tahoma size 48. Colours: As per the current naval recruiting badge.

Q4) It is to our understanding that you are open to different-looking items, and that the pictures provided are only examples of what you are looking for? Can you please confirm, as the items you are giving as examples of the requirement are made abroad – at least the jacket is?

A4) The image provided is an example and does not have to be the product proposed. Alternatives are acceptable.
