The Contractor grants to Canada the irrevocable option to acquire up to 1 additional aluminum hull vessel as described in the Technical Statement of Requirements in the Contract under the same conditions and at the prices stated in the Contract or negotiated by Canada. The option may only be exercised by the Contracting Authority and will be evidenced, for administrative purposes only, through a contract amendment.

The Contracting Authority may exercise the option at any time up to 1 year after the delivery date of the initial aluminum hull vessel by sending a written notice to the Contractor.
