This amendment is being raised to extend the solicitation closing date and distribute the answers to bidder questions.

A) BID CLOSING DATE

The closing date for tender 5P420-18-0064/A, titled *TCH Beaver Valley Ponding Phase 2, Mounds Avalanche Berm, Beaver Hill Rock Scaling - Glacier National Park* is extended from June 5, 2018 until June 6, 2018 at 2:00PM Mountain Daylight Time (MDT).

B) QUESTIONS

Q6 What is the design avalanche return period for the catchment dam?

A6 *Dynamic and static external loadings have been considered and have informed the geometric design provided. As such, the Contractor shall bid the reinforced earth slopes in accordance with the information provided in the Contract Documents at the time of tender, Refer to Section 32 32 34 and the IFT Drawings.*

Q7 What are the design wet snow and dry snow avalanche impact loads including vertical and lateral load distributions to the upslope face of the catching dam?

Q8 What snow and / or avalanche deposit surcharge loads were used on the catchment dam design?

A8 *Refer to Answer 6*

Q9 What is the Target Minimum Factor of Safety for the catchment dam front face considering dynamic avalanche impact loads and seismic loads?

Q10 Was a seismic event releasing an avalanche and both design loads occurring simultaneously considered for the catchment dam design?

A10 *Refer to Answer 6*

Q11 Is the water table level expected to exceed the base of the uphill side of the catchment dam?

Q12 Item 3-b-I states that payment will be based on cross sections taken in the finished fill sections (page 99) so my question would be " if work has not been completed in 2018 on the East Gate Landslide section and there is a slide event over the winter that increases the volume of borrow cut to be removed, how will payment be made for any increase of the borrow quantities ?
