This amendment is raised to publish questions and answers.

Q1 – We don't manufacture Evidence Bags but we represent 2 suppliers (including a Canadian Manufacturer) who competitively make them for us and we successfully compete in the marketplace with these products.

M1 – For your Mandatory Criteria states "The Offeror must have the capability to produce in-house runs of at least 60,000 Evidence Bags. No corporate experience gained through subcontractors will be accepted or reviewed."

A1 – If you do not manufacture Evidence Bags then you do not meet the Mandatory Criteria M1.

Q2 – What was the previous awarded contract value and which firm was awarded?

A2 – This is the first Request for Standing Offer (RFSO) for this requirement.

Therefore there is no previous Standing Offer.

Q3 – I understand the bags are provided on an as needed basis, but what is the typical order quantity per order or size of bags?

A3 – The estimated year usage is indicated on Annex B – Pricing. The typical order quantity per order of the bags is not known as they are required on an as and when needed basis.

Q4 – Custom Evidence Bags have minimum quantities to manufacture for each different size. Also, there are over/under +/-10% variance on manufacturing runs. Will this be acceptable?

A4 – No this is not acceptable.

Overruns and/or Underruns are not acceptable.

Q5 – In regards to the samples, we will not be able to provide the exact bags however we will provide samples with similar dimensions and specifications.

Please note that the thickness requested is much higher than the industry standard so the samples will not have a good representation of the mil gauge. Will this be acceptable? M2 and M3 – You require 3 samples of the R634/R635 and R636 to be 4.25 mil.

A5 – No this is not acceptable.

As indicated in the Mandatory Criteria.

M2 – Samples

As part of the technical evaluation, to confirm an Offeror's capability of meeting the technical requirements, three (3) samples of the R634, R635 and R636 must be submitted with the Bid.

The Offeror must ensure that the required samples are manufactured in accordance with the Statement of Work (SOW) and are representative of the bid submitted. Rejection of the samples will result in the bid being declared non-responsive.

Q6 – You have provided estimated usage per year for Items 1 to 3 in Annex B. In order to run and manufacture custom print bags, there are minimum quantities for each size. In such a scenario where ordering quantities are not guaranteed, will the Ministry provide a blanket PO or guarantee all the custom print bags will be purchased?

A6 – No.

Q7 – Is the artwork/template on the bags new or design currently in use?

A7 –The artwork/template are new.
