If this is the contractor's responsibility please provide a list of acceptable Cx agents who are permitted to complete the work and who have the required security clearances.

Commissioning shall be a line item in the Contractor's breakdown. It is the Contractor's responsibility to ensure that the Cx agents have the necessary security clearances. We do not provide lists of Cx agents or contractors.

Question 3

Please confirm that VAV boxes and humidifier are not required to be included in the commissioning process as listed on page 3, Section 01 91 31 , 1.7. If this is required please identify the number of VAV boxes that are required to be commissioned and please provide a mechanical layout drawing.
