This amendment #003 to the solicitation is raised to provide the questions and answers set #3:

1. Questions and Answers set #3

**Question 10:** Are the drawings available in a CAD file format?

**Answer 10:** Yes.

**Question 11:** In 1b-12, the furniture typical indicates a cushion for the top of storage component, but the GoCUID code provided in Annex A corresponds to a desk. Please clarify.

**Answer 11:** 1b-12 is a cushion, GoCUID code: SPLSxxFAxxxxxCSxxxxxx, as per the SA documents provided.

**Question 12:** For 1b-3, the table indicates a worksurface but the GoCUID code provided indicates a credenza. Please clarify.

**Answer 12:** 1B-3 is a worksurface, GoCUID code: WSxxHGLHRxxxxxxx2424, as per the SA documents provided.

**Question 13:** The RFB stipulates that the bidders certify that the submission includes components to create and fulfill Annex C and the corresponding full furniture floorplan. Can you confirm that we are to match the floorplan instead of matching the table?

**Answer 13:** Please identify discrepancies between the floorplan and table during the solicitation period.

**Question 14:** Due to the number of items that require clarification, please provide an extension to the closing date. A minimum of one full week after posting on amendment would be recommended.

**Answer 14:** No. This tender cannot be further extended.

**Question 15:** Are base or ceiling feeds required and at what locations? This is critical for correct and economical specifying of electrical components.

**Answer 15:** Base feeds, as answered previously in question #5. Feeds are to be provided through the center spine (1a-4 and 1a-5) between two adjacent workstations, see attached images.



**Question 16:** Is a framed glass add-on or a glass screen required?

**Answer 16:** Framed glass add-on.

**Question 17:** Is laminate mandatory, or can we provide a more cost effective option (ie Fabric)?

**Answer 17:** Yes, laminate.

**Question 18:** Is laminate required on both sides of the panels, or can we do laminate corridor side and fabric user side?

**Answer 18:** Yes, laminate on both sides of panels.

**Question 19:** Are whiteboard surfaces required on both sides of the panel? Panels behind the storage unit with whiteboard on both sides is not advisable or cost effective.

**Answer 19:** Marker board (whiteboard) is required for the upper element.

**Question 20:** WS1 & WS2: both typical shows power required on item 1a-4 but Annex A states a 'Non-Powered' panel, please confirm.

**Answer 20:** No power required, please reference answer for question #6.

**Question 21:** WS2: Can you confirm if panels 1a-2, 1a-3 & 1a-5 to follow WS1 Typ. and Annex A panel description?

**Answer 21:** Can you please elaborate? Panels 1a-2, 1a-3, and 1a-5 are as noted in the Furniture Typical Descriptions package.

**Question 22:** Please confirm below if correct and which Code Not to follow:

**Answer 22:** Codes under Annex C should be followed as these match what was provided in the SA documents (typical descriptions and summary documents).
