### **AMENDMENT 001**

This Amendment 001 is raised to respond to supplier inquiries.

Q1) Regarding Section 3.2.3 under Inspection and Maintenance of Overhead Cranes & Hoists Various Areas: Are all these things to be checked for each of the Cranes & Hoists listed in Section 1.2?

A1) Yes, all points listed are to be checked for each Crane & Hoist as applicable.

Q2) Our price will be based upon the number of Overhead Cranes, Hoists, Vehicle Lifts and Loading Docks that you have listed in the tender. If the high bidder is on site and comes across one or more units not listed in the contract, it is agreed that there will be additional charges for us to inspect those as well, correct?

A2) In the event that additional services are required, they will be requested with a Task Authorization. The firm portions of inspection work to be undertaken under the Contract is based on the number of cranes, hoists, lifts and docks indicated in Annex "A".

Q3) Service Call Rate - If inspections are scheduled to be done in a week's time or 2 weeks' time, will the Service Call Rate be paid for each day that we are on site to do the inspections?

A3) The Service call rate applies once for each day that services are requested. For example, work to take place over two days would have the call rate apply twice, thrice for three days' work, etc.
