2) Given that patrol data may also include items such as aircraft track, radar target tracks, automatic identification system detections, operator target ancillary data, target classifications, target identifications, chat data, etc., can Canada clarify if satellite communications costs for transmission of this data is also reimbursable to the Contractor, or does the "only" referred to in the amendment refer to "only" photography and video as being reimbursable?
