PART 1 - GENERAL INFORMATION

1.1 Introduction

The Request for Standing Offers (RFSO) is divided into six parts plus attachments and annexes, as follows:

- Part 1 General Information: provides a general description of the requirement;
- Part 2 Offeror Instructions: provides the instructions applicable to the clauses and conditions of the RFSO;
- Part 3 Offer Preparation Instructions: provides offerors with instructions on how to prepare their offer to address the evaluation criteria specified;
- Part 4 Evaluation Procedures and Basis of Selection: indicates how the evaluation will be conducted, the evaluation criteria which must be addressed in the offer, and the basis of selection;
- Part 5 Certifications and Additional Information: includes the certifications and additional information to be provided;
- Part 6 6A, Standing Offer, and 6B, Resulting Contract Clauses:

1.2 Summary

1.2.1 This Regional Individual Standing Offer (RISO) is required to supply, as and when ordered, locksmith products, weather stripping a full line of lock hardware, door lock , door closer , cylinder and accessories (key blanks) produced by various manufacturers, such as Corbin, Falcon, Norton, Schlage, Von Duprin, Lori Kit, Adams Rite, Weiser, Yale, Ilco, Unique, Abloy, Kaba, Stanley, Prolab, LCN National Guard, Major, Sargent, Labco, Vanderguard, Master, Abus. PART 3 - OFFER PREPARATION INSTRUCTIONS

3.1 Offer Preparation Instructions

Canada requests that bidders provide their bid in separately bound sections as follows:

- Section I: Financial Bid (1 hard copie)
- Section II: Certifications (1 hard copie)

Canada requests that offerors follow the format instructions described below in the preparation of hard copy of their offer:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to the RFSO.

Prices must appear in the financial offer only. No prices must be indicated in any other section of the offer.

3.1.1 Electronic Payment of Invoices - Offer

PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

4.1 Evaluation Procedures

Offers will be assessed in accordance with the entire requirement of the Request for Standing Offers including the technical and financial evaluation criteria.

4.1.1 Technical Evaluation

4.1.1.1 Mandatory Technical Criteria

- a. The offeror must provide the brands of products asked Annexes "B" and "C". Equivalencies will not be accepted because of military security standards.
- b. The offeror must provide a minimum of 90% of the total items listed in Annexes "B" and "C" for the entire period of the Standing Offer including the 2 option years.
IMPORTANT: The minimum number of items where a price must be submitted is as follows:
 - Annex "B": 84 items, and
 - Annex "C": 14 items.

4.1.2 Financial Evaluation

The **total** price of all items in Annexes "B" and "C" for the offer period including the two (2) optional periods of one year each will be considered for the evaluation of the offers.

4.1.2.1 Method of calculation used

For evaluation purposes only, the total price of the offer will be calculated by multiplying the unit prices by the estimated quantities as listed in Annexes "B" and "C" for the entire period of the Standing Offer including the two (2) option years. If a discount percentage is proposed, it will be applied to the total amount of your proposal including the 2 option years.

- *It should be noted that for all items where no unit price is indicated by an offeror, the insertion of the price of the offeror with the highest unit price for the same item will be inserted in order to evaluate all offerors fairly.*

4.1.2.2 Evaluation of Price

The price of the offer will be evaluated in Canadian dollars, excluding the applicable taxes, FOB destination including all delivery, packaging, shipping, handling and unloading charges to destination, Canadian Customs duties and excise taxes included if applicable.

PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION

Offerors must provide the required certifications and additional information to be issued a standing offer.

The certifications provided by offerors to Canada are subject to verification by Canada at all times. Unless specified otherwise, Canada will declare an offer non-responsive, will have the right to set-aside a standing offer, or will declare a contractor in default if any certification made by the Offeror is found to be untrue whether made knowingly or unknowingly during the offer evaluation period, during the Standing Offer period, or during the contract period.

The Standing Offer Authority will have the right to ask for additional information to verify the Offeror's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Standing Offer Authority will render the offer non-responsive, result in the setting aside of the Standing Offer or constitute a default under the Contract.

5.1 Certifications Required with the Offer
