
**ADDENDUM NO. 2
TO THE

TO ALL PROPONENTS

The purpose of this ADDENDUM is to provide responses to questions received.

Questions and Responses:

- 1. Question:** Is electricity available on the island to run our heavy load 83 equipment on the Island?

Response: *No. Per Specification Reference 01 11 00 - 1.9.1; The Contractor to provide all services to complete work. Specification Reference 01 11 06 - 1.10.1; The use of any existing on-site services (e.g. water, sanitary, and electrical) is not permitted. Specification Reference 01 14 00 - 1.1.3; The Contractor to provide all requirements to complete work including power. Specification Reference 01 51 00 - 1.6; The Contractor shall provide temporary power.*

- 2. Question: a)** [Are] there any facilities on Island available for our crew to stay on site overnight for few days?
b) If yes, will there be all basic requirement available like water, bed, fridge and stove, etc? This will save transportation cost a lot.
c) If these accommodation are available for contractors, then please provide cost associated with this.

Response: a) *Yes. Per Specification Reference 01 11 06 - 1.10.7; The Contractor may use existing structures (i.e. Living Quarters building and garage/living quarters building), observed during the Mandatory Site Visit, for worker accommodations, subject to the requirements of the Specification to clean and disinfect prior to use. Note any accommodation provided to workers on site shall be provided to the DEPARTMENT REPRESENTATIVE and the Owner's Team as stipulated in the Specification.*

b) *Basic requirements as indicated in the question are to be provided if not observed during the Mandatory Site Visit. Per Specification Reference 01 11 00 - 1.9.1; The Contractor to provide all services to complete work, including water. The working condition of any appliances (e.g. fridge, stove) is unknown. Specification Reference 01 11 06 - 1.10.2; The Contractor to provide all temporary facilities and services, including accommodation measures, if Contractor provides on-site accommodations during the project.*

c) Per Specification Reference 01 11 00 - 1.8.4; The Contractor has unrestricted use of the site, as such, no cost is associated with the use of the existing structures for accommodation. However, per Specification Reference 01 14 00 - 1.1.3 The Contractor to provide all requirements to complete the work including, but not limited to, own water, power, light, etc. Per Specification Reference 01 11 00 - 1.9.1; The Contractor to provide all services to complete work, including water. Specification Reference 01 11 06 - 1.10.2; The Contractor to provide all temporary facilities and services, including accommodation measures, if Contractor provides on-site accommodations during the project. As such, all cost associated with providing these and maintaining the same is the responsibility of the Contractor.
