Title: Deployed Logistics Support Services (DLSS) – Continental Africa

Solicitation Amendment No. 001

This solicitation is hereby amended to provide the following question and answer:

Q1. The Request for Standing Offer (RFSO) clearly requires a Contractor to be able to provide Deployed Logistics Support Services (DLSS) with short notice, in each of over 50 different African Countries. This is understandable considering that a real operation of humanitarian assistance, disaster relief or peacekeeping could be requested anywhere. Notwithstanding this general requirement, would it be possible to have some indications on which will be, in particular, the African Countries where the Exercises will be more realistically carried out?

If it is not possible to provide this estimate, would it be possible to have at least the complete and detailed list of the African Countries covered by the resulting Standing Offer (SO), in order to better identify the key locations of the SO?

A1. Currently, the Canadian Armed Forces (CAF) conducts ongoing operations in Democratic Republic of the Congo, Niger, the Republic of South Sudan and the Gulf of Guinea. In the future, it is expected that CAF operations in Africa will increase in number and scale, including further countries that the CAF does not currently operate in. At this time, it is difficult to detail exactly which countries the CAF will operate in over the next five years, however, so the Contractor must be prepared to provide services under the Standing Offer in all African countries.

If your bid has already been forwarded and you wish to revise same, this revision should be sent in a sealed envelope and mailed to the above address and reach the undersigned before the appropriate closing date. The solicitation number and the closing date are to be shown on the outside of the sealed envelope.

All other terms and conditions of the solicitation document remain unchanged.
