Questions and Answers:

Q1. Will Canada consider supplying slightly larger HP, counter rotating motors?

A1. Canada can supply twin 115 hp Yamaha outboards for each boat.

Q2. In the TSOR, Section 4.2 and 5.1 mention a tandem seat configuration while section 5.7, which describes the seats in detail, calls for two seats side by side. Can Canada confirm which configuration they envisage in these boats?

A2. Side by side is the required configuration.

Q3. Will Canada allow the "engine pod" to be considered as additional to the Length overall of 6.4 – 6.5m?

A3. The engine pod must be in addition to the 6.4 -6.5m length.

4. In this RFP, only the option proposed by the successful bidder may be considered by Canada.

5. The option, if incorporated into the Contract, in whole or in part, may or may not be exercised at the sole discretion of Canada.
