<b>Question 3</b>	We have a product that meets your specifications for proposal W8476-195936/A (Tactical Air Control Party Headset Assembly), but in order to get it in the country we respectfully request that it might be possible to either extend the timeframe for the sample or the solicitation itself?  2-4 weeks would make it safe for us.

<b>Question 4</b>	In reference to the amendment 1, For offering an equivalent product we do need to extend the closing date for couple of weeks. Therefore, as this is very sensitive product, I appreciate if you could provide us with more time to prepare a suitable bid which meet all requirements.
