QUESTION 1

7.4.1

Would a delivery date after September 24th, 2018 be acceptable?

RESPONSE 1

Original requested delivery date has been modified to October 31, 2018.

QUESTION 2

The Aluminum Hull Vessel (5P310-180272/A) solicitation and TSOR indicate that Parks Canada will be supplying and installing the outboard engines. If Parks Canada will be installing the engines themselves we must assume that we will be required to deliver a vessel to Parks Canada with loose steering gear and fuel line connections that has not been sea trialed. Are we right in our assumption that Parks Canada is looking to complete these connections and sea trial themselves or is the TSOR incorrect in stating that Parks Canada will be installing the outboards? Typically the outboards are supplied to the Contractor for installation to allow for connections and sea trials.

RESPONSE 2

The outboard motors will be government supplied material (GSM) by Parks Canada and will be installed by the contractor.

QUESTION 3

Can you clarify whether or not the winning bidder will be required to complete sea trials for Aluminum Hull Vessel (5P310-180272/A)?

RESPONSE 3
