QUESTIONS AND ANSWERS – SERIES VI

- Q1. Attachment 1 to Part 4 section "Benching and Activity Based System (different series, same manufacturer - if applicable)" has titles slightly different than those of the typicals. We can assume that; Individual Workstation = Typical A 1 Pod, Cluster Workstation = Typical A 2 Pod, Height Adjustable Benching Workstation = Typical C, and Fixed Benching workstation = Typical D. The confusion is with the title "Architectural Storage" as the only reference to this in the typicals was in the deleted Typical B (amendment 007). Are we to simply note that Architectural Storage is not applicable due to the deletion of Typical B? If not, what are we supposed to include in this section?
- A1. Refer to Attachment 1 to Annex A – Product Specification section 11 - BENCHING AND ACTIVITY BASED SYSTEMS for specifications and also to Attachment 1 to Part 4 Financial Presentation Sheet - Architectural Storage section to be completed. An entire line/series of product is to be proposed meeting the specifications in Attachment 1 to Annex A.
