- 1) Address questions posed concerning the solicitation.

1. Response to questions:

Questions	Reference	Answers:
1. Please confirm that the "high quality" aspect of the required colour printer on each aircraft be 4800 x 2400 dpi or higher. In researching available COTS airborne printers that meet <i>ARINC</i> standards, the highest resolution available is 4800 x 1200 dpi colour. Would Canada accept a 4800 x 1200 dpi colour printer on each aircraft as the Contractor solution?	SOW 11.8.24 Printer	Canada will not be applying the ARINC standard for this requirement and continues to require a 4800 x 2400 dpi or higher colour printer on each aircraft as outlined in SOW 11.8.24.
2. For the detection of a fishing vessel (12.6 m in average length) at 10,000 ft altitude, the stated DFO requirement is 70km slant range for Day. In developing a demonstration of capability for this standard with Wescam, the minimum slant range for this type of target is 60km given the mean environmental conditions. Further, Wescam indicates that detection at greater than 60km is impossible given current technology for any EO/IR system commercially available today. Would Canada consider adjusting the minimum detection slant range for the Fishing Vessel to 60km?	SOW 12.2.2.6 EO/IR minimum ranges	Canada's technical assessment is that the required range is within commercially available capacities. Accordingly, Canada continues to require the EO/IR minimum ranges as identified in SOW 12.2.2.6.
