A) Bidders' questions :

Question 3: Can we do the typeset in Indesign or it has to be MS Word?

Response 3: Indesign is fine; Typeset does not have to be in MS Word.

Question 4: May draft proofs be provided in PDF format or must they be provide in word and only the final proof is in pdf format.

Response 4: Draft proofs must be provided in PDF format.

Question 5: Do the final typeset documents have to be delivered in Word? Or just as a PDF?

Response 5: Final typeset documents must be delivered in PDF format.

Question 6: From the tender notice, it sounds like Supreme Court Reports is using a more manual process of word processing files being laid out in desktop publishing software. Has SCR considered a software-based solution that structures content, automates layout and enables multichannel (Web, database, smartphone) publishing?"

Response 6: The current requirement is for the typesetting, page formatting, and page layout services of the Supreme Court Reports as specified in the Annex "A" Statement of Work. The typesetting, page formatting, and page layout of the Supreme Court Reports must follow the standards established by the Supreme Court of Canada and demonstrated in the provided samples from previous productions.

All other terms and conditions remain unchanged.
