A. Questions & Answers

- Q1. Under Annex A Statement of work under section 3.1 Product specifications, we had a question about the Circulation on slopes: Minimum 8% with a load

 Minimum 15% without a load

 What is the actual slope that must be navigated and would 10% gradeability be acceptable?
- A1. The actual slope cannot be specified because each CRA building will have a different one, which is why a minimum of 15% without a load was chosen, as it would likely be acceptable for all locations. However, CRA can accept a 10% gradeability, therefore it will be updated in the RFP. Please refer to Amendment #1 to the RFP, located in the section below.
- Q2. Under the same section of Annex A Statement of Work, it is stated that the width of individual forks (width of each fork blade) is a maximum of 25 cm (250mm) Can you accept 254mm?
- A2. Yes, CRA can accept a maximum of 25.4 cm (254mm). Please review Amendment #2 to the RFP, located in the section below.
- Q3. Under the same secton of Annex A Statement of Work, it states that the enclosed operator ride on pallet transport truck must also include a Keypad start. Would a keyless, on/off switch be acceptable in lieu of a keypad?
- A3. Unfortunately, a keypad is mandatory due to security reasons.
- Q4. Under Annex A Statement of Work, Section 5.0 DELIVERABLES, under section i) for the "as and when requested" work, the Contractor must supply, deliver, and assemble, (as needed), all products no later than fifteen (15) weeks from the date of receiving a Task Authorization. This delivery lead time may be difficult to achieve. Can the requirement be extended to delivery/installation within 18 weeks?
- A4. The CRA agrees to extend the delivery time periods from 15 weeks to up to 18 weeks for both the "as and when requested" portion of the work, as well as for the firm requirement. CRA agrees that this is a reasonable timeframe for this commodity. Please refer to Amendment #3 to this RFP, located in the section below.

Amend #1: Under Annex A: Statement of Work, section 3.0 PRODUCT REQUIREMENTS, subsection 3.1 Product Specification, located on pages 30-31 of 34:

3. To establish the Pricing score, the Bidder's Bid Evaluation Score (as outlined in Appendix 3 – Financial Proposal) will be divided by the total points available (7,000 points) and multiplied by the ratio of 70%.
