- A2. As stated in Part 1 – General Information, article 1.2.6, PSPC may issue up to 2 Standing Offers for each package (under Stage 1) and/or 2 Standing Offers for each item (under Stage 2), for the items listed in the Product Requirements List per stream. At Stage 1, all responsive offers for an entire package(s) will be evaluated first. The top 2 responsive offers with the highest ranking by package will be recommended for award of a standing offer. At Stage 2, all responsive offers for individual items will be evaluated by item. The top 2 responsive offers with the highest ranking by item will be recommended for award of a standing offer. If issued a standing offer agreement, the Offeror must provide the entire line of products of the Offered Product(s) throughout the duration of the Standing Offer as indicated in Mandatory Technical Criteria MTC 6.

THIS AMENDMENT IS RAISED TO CHANGE THE REQUEST FOR STANDING OFFER (RFSO) SOLICITATION. THE FOLLOWING REVISIONS ARE:

1. At Request for Standing Offer cover page, solicitation closing box, DELETE in its entirety and REPLACE with the following,

2. At Part 1 – General Information, article 1.2.6, ADD the following,

“Upon issuance of a Standing Offer under Stage 1, the Standing Offer holder must provide the entire line of products for each Offered Product within the package throughout the duration of the Standing Offer. The entire line of product includes the other configurations and variations for each Offered Product within the package. The MSRP percentage discount(s) must be the same as the Offered Product(s).

Similarly, upon issuance of a Standing Offer under Stage 2, the Standing Offer holder must provide the entire line of products for each Offered Product throughout the duration of the Standing Offer. The entire line of products include the other configurations and variations for each Offered Product. The MSRP percentage discount(s) must be the same as the Offered Product(s).”
