# **Questions and Answer Part 2**

- Q1) The schedule seems to be missing a named manufacturer for the RTUs as well as the condensers. Would you be able to provide us with one?
- A1) No changes, approved or equivalent model is shown in schedule. AC unit; will add to addendum; very basic 2 Ton split DX. All information is available on drawings to select from their preferred vendors, but will add model anyway.
- Q2) The silencers on the drawings have no listed dimensions in the specs, and no length in the drawings. They seem to be placed at locations that fire dampers might be located. Could you advise and correct the drawing if need be?
- A2) Silencers: No changes; drawings have sufficient information for manufacturer to size silencers. Frequencies, maximum velocity, maximum pressure drop, size of duct; the length is calculated by the silencer manufacturer as a result of that information. Silencers Fire Dampers No changes; We are only crossing one fire separation with silencers (3 silencers in room 102). The silencers will be installed after the fire damper (not in the wall as shown on drawings).
- Q3) Can you please confirm that the RTU's are packaged rooftop units with all controls factory mounted? I.e. We would Bacnet integrate to this unit for BAS monitoring.
- A3) Yes rooftop unit controls are factory mounted (addendum will clarify).
- Q4) Please confirm that the 3 x A/C units are stand alone and do not require BAS tie-in.
- A4) Added to specifications start/stop, alarm & status, will be addressed addendum;

- Q5) The sequence of operations in section 25 90 01, speaks to no tie in of the Exhaust Fans on the Building Automation System although I see that EF-4 (in the schedule on drawing M400) should be started and stopped on the EMCS schedule: Is this what is actually required for EF-4? Please confirm.
- A5) Added to specifications EF-4 by EMCS schedule, addendum will clarify
- Q6) Is the intent to have electric reheat on these 20 x VAV units? And, Is the actuator actually coming packaged with the VAVs so we do not need to provide one on our end? Please confirm
- A6) Modified schedule to remove reheat and actuator by VAV manufacturer, addendum will clarify
- Q7) Can you please confirm the training requirements for our BAS. As per section 25 01 12 (EMCS: TRAINING), we are being asked to provide a 2-phased training approach which represents approximately 7 days of full BAS training onsite (approximately 53 hours of tech time). Would this not be excessive for such a basic BAS? Please confirm what the final intent for the training program is. Typically we often see approximately 2 days: One at the system turnover time and another day several months down the road. Would this be considered sufficient?
- A7) Training requirements modified, addendum will clarify
- Q8) Can we get a list of General Contractors bidding so we can send them our millwork price?
- A8) A full list is not available. Please see 'List of Interested Suppliers' on the main tender page. This list is voluntary.
- Q9) Is there an address for this building?
- A9) No exact address available. Located in Ottawa (East End), Ontario,
- Q10) Will the RCMP remove Mandatory Requirement M2
- A10) RF Shielding is a major component of the construction. Therefore we will keep the M2 requirement.
- Q11) Will a geotechnical report be issued?
- A11) Answer in Amend. #1.

- Q12) Can you please provide a preferred manufacturer for the fence? The specification/details call for chain link fencing with 3"x0.5" mesh.
- A12) Not provided
- Q13) Drawing E-001, note 8: Please clarify if supplied by the owner or the contractor. Also, the drawing does not show where the conduit will pass.
- A13) Note 8 reads 'Provide', where provide indicates "Supply, install and connect" as per legend item in drawing E000. Conduit runs to be as per note 2 on drawing E401 and detail 1, Site Plan Ancillary Systems.
- Q14) Can you confirm when the anticipated start date is?
- A14) Upon contract award
- Q15) Can you confirm the duration of the project?
- A15) See BA06 Construction Time in the Bid and Acceptance Form
