As stated in Part 1 – General Information, article 1.2.6, “The top five (5) ranked responsive offers per item in each stream with the highest financial score will be recommended for issuance of a standing offer agreement.” An offeror will be evaluated for each offered product. If issued a standing offer agreement, the Offeror must provide the entire line of products of the Offered Product(s) throughout the duration of the Standing Offer as indicated in Mandatory Technical Criteria MTC 5.

- Q3. At Attachment 1 to Part 4 – Financial Presentation Sheet, Basket of Product Pricing column, what information is required to complete this section?
- A3. PSPC will complete the Basket of Product Pricing column. This section is not to be completed by the Offeror.
