The purpose of this amendment is to:

- A) To update the Annex "B" Basis of Payment to reflect the responses provided in response to Bidders' questions.

A) ANSWER BIDDERS' QUESTIONS

Question 6: We have found some issues in Annex B (for both contract period and all option tabs). Please confirm if the following should be changed. Cell Reference number is for the English Annex B

- a) B.4.40.d shows Addl 50,000 copies (should it be 100,000?) - H2332
- b) B.4.48.0.a shows Basic 5,000 copies (should it be 500?) – H2512
- c) Envelopes (starting B.4.50) – Do you want pricing for open end OR open side? – H2560 / H2579

Response 6: This is correct. For the contract period (B.4 A) the option years B.4(B); B.4(C); and B.4(D), the following changes will be made to the English excel spreadsheet:

B.4.40.d under Bookmarks should read Addl 100,000.
B.4.48.a under Fact sheet should be "basic 500 copies"; and
B.4.50 Large Envelopes: pricing is for open side envelopes
B.4.51 Envelopes (Invitation [B]): pricing is for open side envelopes.

The French Annexe B MS excel spreadsheet is correct except for the Envelopes. B.4.50 and B.51 (contract period and option years) are amended like the English spreadsheet.

Annex B English version is amended as follows. Bidders must download and fill out the amended MS Excel spreadsheet.
