AMENDMENT 002

This amendment is raised to:

1. extend the closing date;
 2. publish question and answer 002; and
 3. amend Annex "B" – Purchase Description.

1. The closing date of this solicitation is extended as follows:

Delete: Solicitation closes at 14:00 EDT on 2018-07-25

Insert: Solicitation closes at 14:00 EDT on 2018-08-08

2. Question and Answer 002 is as follows:

Question 002: Annex "B" – Purchase Description, paragraph 3.6.2 – Soft Removable Cab – The vehicle must be provided with a soft removable cab.

In our extensive experience with truck mounted forklifts, we have tried soft removable cabs several times and they have proven to be inappropriate and non-functional. The issues are poor visibility, which gets worse quickly with dirt and each cleaning, and a short lifetime due to wind and contamination.

We strongly recommend a solid steel and glass cab which meets FOPS and ROPS standards and includes a windshield wiper, heater and fan. This is a common option on our truck mounted forklifts and is popular in northern Canadian locations. Will the requirement be changed to a much more suitable steel and glass cab with wiper, heater and fan?

Answer 002: A regular commercial standard steel and glass cab for this type of forklift will be acceptable for this application.

Section 3.6 of the Purchase Description have been modified accordingly.

3. Annex "B" – Purchase Description is amended as follows:

Delete: Section 3.6 in its entirety; and

Insert: 3.6 **Operator Station**

3.6.1 **Cab**

- (a) The vehicle **must** be provided with a Falling Object Protective Structure (FOPS) and Rollover Protective Structure (ROPS) certified cab for the protection of the operator;
- (b) The cab **must** be provided with a fan;

- (c) The cab **must** be provided with a windshield wiper and washer system for the front and rear windows;
 - (d) The cab **must** be provided with two (2) opening windows, one on each side, as an emergency escape route; and
 - (e) The vehicle **must** be provided with a load chart in cab showing load capacities at various lift heights.
- 3.6.2 **Operator's Seat**
- (a) The vehicle cab **must** be provided with a fully suspension operator's seat with a backrest and seatbelt;
 - (b) The operator's seat **must** be fore/aft and vertically adjustable without having to have the operator move from the seated position.
- 3.6.3 **Mirror(s)** – The operator station **must** be provided with rear view mirror(s) positioned providing a full view of both sides for safe reverse operations

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.
