Solicitation Amendment 003

This amendment is raised to address the following question:

Question No. 3:

Requesting clarification on the following requirement within the Submission Requirements and Evaluation for the above Solicitation.

Clause SRE 3.2.5 (3) notes that "Past expertise and experience of personnel not within the Proponent's (or joint venture Proponent's) organization will not be considered in the evaluation."

Could you clarify which of the following is intended. Is it intended that this refers to:

1. Personnel not within the Proponent's organization; or
2. Experience gained by personnel, when that experience is not with the Proponent's organization, even though the person is employed by the organization (i.e. the relevant experience was gained prior to joining the Proponent).

Response:

Further to SRE 3.2.5(3) which reads " In-house personnel means personnel within the Proponent's organization (see definition of Proponent in General Instructions GI 1). Past expertise and experience of personnel not within the Proponent's (or joint venture Proponent's) organization will not be considered in the evaluation."

If the personnel with specific experience or expertise has left the Proponent's organization, that personnel's experience or expertise will not be considered for evaluation.

All other terms and conditions remain unchanged.
