Solicitation Amendment No. 001

Title: Fitness Equipment,

This solicitation is hereby amended to provide the following questions and answers:

Q1. In order to be compliant, does a bidder need to bid on every item in the tender or in each grouping?

A1. Yes, the bidder must comply with **all** requirements of the bid solicitation and meet **all** the mandatory technical evaluation criteria for **each** item in Annex "A".

Q2. Will only 1 bidder receive a contract?

A2. Yes, one contract will be awarded.

Q3. Where it states "removal and relocation of existing equipment", does this mean just moving the equipment to other sites or does it mean the bidder must buy back the used equipment?

A3. The existing Equipment, which is in M-2 is to be removed and relocated to a storage facility to the rear of M-2, approximately 200m. The equipment will remain the property of the Military Sports Facility.
