QUESTIONS AND ANSWERS (1 to 6)

1. Outside of the provided 2 parking spots as outlined in Annex "A" 11.6, is there parking onsite for our staff, particularly on days – is there any charge?

Yes and no charge

2. In relation to Annex A - 11.3 can we please have the building locations for the items listed (office, stock rooms, etc...).

The provided office and stock room will be room B-71, in building 20, all other buildings have either a janitor's closet or designated area with a cupboard for equipment and supplies.

3. Is there water & sewage available in all buildings?

Yes

Are there janitor closets available in all buildings?

Yes, most have 1 closet or more, depending on the size of the building and some (few) have a designated area with a cupboard within a room or area.

If not, please indicate which buildings do have janitor closets.

4. Minimal work has been specified for weekends & stat holidays. Is there any specific staffing requirement for these days?

No, a minimum of one cleaner is required.

5. We see that there is identification of High, Medium and Low Occupancy in the buildings as provided in document 01b46-191445_annex_k_.pdf. In terms of establishing the consumable requirements, is it possible to have the number of staff working by building and the number of visitors to the site?

See attached spreadsheet for approximate staff by building (931) and there are visitors but no data is available.

Alternatively is it possible to have the total consumable consumption totals for the washrooms?

No, we do not have that information.

6. Could you please clarify the numbers associated with Building 12? We have a few different totals of the area to be cleaned based on the numbers provided in the RFP. ***Total area to be cleaned is 401.9 M³. (Flooring + carpeting + outside runs) Revised floor plan is attached but other annexes will need to be updated/revised also.***
