THE FOLLOWING CHANGES IN THE TENDER DOCUMENTS ARE EFFECTIVE IMMEDIATELY.

Q1: Is all the excavation & concrete work done by the general contractor? If so, note 1 on drawing E-001 mentions that it is done by the electrical contractor.

A1: Note 1 only refers to "Bedrock trench may be required". As a General Contractor is on board, it will be the GC's responsibility. For clarity, this wording will be removed part of addendum, including note 3.

Q2: Can you please provide a preferred manufacturer for the fence? The specification/details call for chain link fencing with 3"x0.5" mesh.

A2: There is no preferred manufacturer for the chain link fence.

Q3: Will specifications for the airlocks and shielded doors be issued, I can't find any mention of the product or manufacturer in the specs?

Will it be the General contractors responsibility to supply and install or will these items be covered by the owner.

A3: We are recommending Raymond EMC or equivalent approved. The General Contractor will be responsible for the supply and installation of these items.

Q4: On drawing A800, door types C & D are noted "as per shielded door manufacturer's specifications". Is there a specific required manufacturer? Can these specifications be provided?

A4: The recommended manufacturer is Raymond EMC or equivalent approved. Specifications attached.

Q5: All four of the volume 1 appendices seem to be missing from the specifications. Will they be provided?

A5: Yes see Amendment 3
