Questions and answers

Question 1

In the appendices, it is specified "Check, clean and repair, if necessary". Do the repairs include the price of parts?

Answer : The Contractor must submit prices for the required equipment, as explained at paragraph 1.5 of Section BR:

"The Contractor shall submit to the Departmental Representative all costs for the purchase of materials and equipment for the repair of boiler room equipment, its components and its steam system for approval"

Question 2

At Appendix 4, it is specified :

"Using natural gas

The natural gas regulator must always be inspected and cleaned. The diaphragm must be changed every six (6) months from the date the regulator is used. Record diaphragm changes."

It is not good to play with natural gas regulators periodically every six months. If you have doubts with your regulators, you can put screens upstream and clean the streams.

In addition we are not allowed to replace the diaphragms in the field. You will lose natural gas for a day or two.

In your place, I would have the regulators' vents checked during the monthly and annual inspections. If there are gas leaks, then you can replace the regulator or the diaphragm for repair and not maintenance.

Answer : Appendix 4 has been modified. See MODIFICATION no 1 below.

Conduct a "smoke test" at different speeds, as per current standards and best practices and determine boiler combustion performance at all speeds. The performance should be 80% and above for most speeds; if an inferior level of performance is noted, the Contractor shall, at its own cost, adjust the boiler.
