This amendment is being raised to distribute question and answers.

A) QUESTIONS AND ANSWERS

Q6 The proposal mentions more washrooms may be required in addition to replacing the two in the day use parking lot. Please confirm how many total washrooms will be required at the day use parking lot, and how many at the viewpoint parking lot?

A6 The number of washrooms required will be determined during design utilizing "Appendix A - Bow Lake and Peyto Lake Traffic and Parking Activity" and in conjunction with the field unit's operation restrictions / requirements.

Q7 Is there a standard design detail available for the new washrooms? There are designs available which can be provided upon award.

A7The new design for the washrooms can be a combination of the previous designs.

Q8 Is the Safety Codes Officer a part of the consultant team, Surveyor Qualifications.

A8The Safety Codes Officer shall be a part of the Consultant team.

Q9 Section 10.18.5 discusses a Real Property Report signed and sealed by a Canadian Surveyor. Is an Alberta Land Surveyor acceptable for this project or will they be retained by the CPA as an independent third party?

A9 An Alberta Land Surveyor is acceptable.
