### **Amendment No. 005**

**This amendment is raised to answer bidders' questions:**

**Q1:** Does Canada require pricing for the items listed in the Statement of Work, or just the information requested in Mandatory Requirement 4?

**A1:** An offer must comply with the requirements of the Request for Standing Offers (RFSO) and meet all mandatory technical evaluation criteria to be declared responsive. The requirements include the submission of a Financial Offer as described in Annex B – Basis of Payment, as well as a Technical Offer which responds to all of the Mandatory Technical Criteria as described in Annex C – Technical Evaluation Criteria.

**Q2:** Should Offerors submit the information and photos in any special format?

**A2:** Offerors must enter their prices on the MS Excel spreadsheet supplied on [buyandsell.gc.ca](http://buyandsell.gc.ca) and submit it in Excel format as part of their offer. Offerors must provide a high-definition photo of each item proposed by the Offeror.

**Q3:** We would like to ask for an extension to the RFSO that is workable for Canada?

**A3:** Canada will extend the closing date to August 16, 2018 at 2:00 PM.
