QUESTION 1:

Dental Equipment category in “Objectives of the requirement” section in the items which “form part of the Standing offer” include “Sterilizers and Ultrasonic units”, however these items are not found among the items noted on the sample annex.

Reference page 18 of the RFSO document/ annex “A”/ 1. Scope / 1.2 Objectives of requirement / second column titled “Items which form part of the standing offer” , first cell of your table lists the “Dental Equipment”/ Item 17 and 18 in your list notes sterilizer and ultrasonic.

These items #17 and 18 from your list are not found among the items noted on the sample annex E or F. Is Canada interested in sterilizers and ultrasonic units? Are there any specifications from your end users for this equipment? Would they be table top units or floor models required? It is also recommended that a service contract (beginning after original warranty) for these items be purchased to ensure the longevity and reliability of the equipment.

Please confirm if these items are indeed part of this Standing offer.

RESPONSE 1:

The Standing Offer Agreement (SOA) is for the provision of dental equipment, instruments, handpieces and supplies. Yes, Sterilizers and ultrasonic units will form part of any resulting Standing Offer Agreement under the Dental Equipment category.
