Amendment 001 is raised to answer the following question:

Question 1: With regards to MT1 (a), “Evidence of supportive sensitive client service to at risk or vulnerable individuals dealing with loss or suffering or death; Would the Crown please clarify if the assessment criteria for ‘loss or suffering’ would include individuals suffering from catastrophic financial loss who are provided with the resources, tools and client focused services to help them navigate through this difficult time as financial loss is often directly correlated with personal suffering including, but not limited to emotional crisis and in some cases, impact on children custody, family separation, gaming addiction, etc.

Answer 1: Yes a project that demonstrates evidence to support sensitive client service can include situations that support clients suffering from a serious financial loss.
