This amendment is raised to address the following:

- To respond to questions received during the solicitation period and add addendum No. 1, addendum No. 2, and addendum No. 3 and 17342.001.E_Lighting_Equal[1].

Q1) Would you please advise as to the height of the mobile shelving system and the number of shelves required?

R1) There is a bulkhead in the area where the shelving is to be placed. Site measurements will be necessary.

Pending bulkhead changes.

Q2) Are there any important dates/events during construction that we need to know about?

R2) Canada Day, as well as every noon hour parade-quiet time 12:15 to 1:20 PM (no noisy work during this time)

Q3) For the RCMP Resource Centre Interior Reno there does not appear to be a fixture schedule for lighting / emergency lighting in the Electrical documents.

R3) Page E0.0 on TP2 Drawings shows electrical details

Q4) There does not appear to be a normal window schedule. It just says, "site measure" by the window diagram. Am I reading that correct?

R4) Window schedule, "site measure" is correct.

Q5) The Specs call for roller shades and aluminum louver blinds, but do not indicate which windows need which blinds. I cannot find a "window covering schedule" in any of the attachments. May I request one?

R5) There is no window covering schedule, the TP2 Drawing shows details of which window is a roller shade as well as which window is louver blind.
