

Question	Answer			
Q1. What is the certification of a company to provide Building Workplace Trust training that you are referring to?	A1. We are not referring to any specific company but rather a learning institution or management/leadership organization that develops, designs and delivers a high quality learning product on building workplace trust.			
Q2. What is the accreditation of a company that you are referring to?	A2. The certification or accreditation has to come from the learning institution or management or leadership organization that provides the learning materials for building workplace trust.			
Q3. Who delivers the certification and the accreditation? On who's authority?	A3. The certification and accreditation has to originate from the company that provides the content and that the facilitators meet the quality standards of the delivery of that institution. The company has to be available to train internal staff of the department to meet the quality standards of the delivery.			
	The authority is the department of the government of Canada.			
Q4. Training for Senior Leaders: Do you require one price for 5 sessions of 20 participants? Or a price for one session of 20 participants.	A4. We require one price for one session of 20 participants.			
Q5. Who is the client? and where are the training sessions delivered?	A5. The audience is Directors General and Assistant Deputy Ministers.			
	The training sessions are delivered in the National Capital Region of Ontario.			
Q6. Code of conduct and Certification: When applying jointly do both companies require Government registration with 2 PBN? Or can we rely on just one PBN?	A6. Both companies require a Procurement Business Number.			
Q7. I need to know the number of participants in the internal workshops for each year. That will allow me to calculate the exact price of materials. For example, if each internal facilitator teaches one workshop a month for twelve months, with 24 participants in each workshop, I can give you an accurate price. On the other hand, if the facilitators are dedicated to this training and the demand is higher, you will most likely need a lot more materials.	 A7.
