SOLICITATION AMENDMENT No. 002

This solicitation amendment has been raised to make the following clarification:

The following questions were received regarding the Basis of Payment line item #4:

4A. Question: "For the stairs will it be multiple stairs tied onto a new or existing sidewalk or will it be numerous single stair?"

Answer: This requirement will most often be multiple stairs tied onto new or existing sidewalks. Occasionally 1 riser may be required. Our estimation is that most often the stair requests will range from 3 to 10 risers at 48 inches wide.

4B. Question: "Will this railing be installed on the new stairs, if not approximately how long of runs will it be?"

Answer: This requirement will most often be to install new handrail on new stairs constructed under this Standing Offer. Occasionally failing handrail may be replaced under this SO. Our estimation is that most often the railing will be required for sections of stairs from 3 to 10 risers.
