| 1 | We would like to request an extension to the closing date by two weeks to allow a greater number of bidders an opportunity to respond. | The closing date will be extended to allow bidders to submit their bids accordingly. See Change 1 for the extension. |
| 2 | For each new stream, do we have to provide a reference for all the categories in that stream or only those that we are bidding for? | For each new stream that you're applying, you are only to provide references for the categories you wish to offer. |
| 3 | Can the reference and financial requirements for each category be the same for each stream, since one project with the given reference can overlap multiple streams?? | The reference and financial requirements for each category can be the same for each stream. |
| 4 | I do not remember receiving a 'grandfathered certificate' for our existing learning streams; however, I noticed that the option for this has already been identified in our account. Is this a sufficient response to your criteria for this RFSA/RFSO? | The Grandfather Certificate is required if an existing supplier wishes to rely on the information already on file to demonstrate compliance with the streams and categories they already qualified for during the last re-competition and/or refresh. A signed Grandfathered Certificate will be requested during the bid evaluation period. If you were a new bidder at the last re-competition or refresh, a Grandfather Certificate would not have applied at that time. |
