The meeting location has been updated to the following:

# TO THE SPECIFICATIONS

### SECTION 01 11 00 - SUMMARY OF WORK

Page 1, delete the following in subsection 1.1.2:

"and new fencing surrounding the pump house will be installed."

# Page 2, add the following as subsection 1.5.2:

.2 Contractor is responsible to plan for weather delays and factor them into their travel arrangements/work rotations to complete the project on schedule. The Owner will not consider additional payment for delays associated with what can be reasonably considered normal weather.

# **SECTION 01 29 01 - MEASUREMENT AND PAYMENT**

# Page 2, add the following to the end of subsection 1.2.2:

"This item also includes the provision of food, flights and boat travel."

### Page 3, add the following to the end of subsection 1.5.2:

"This item also includes all costs associated with commissioning, certifications and water quality testing."







# <u>SECTION 01 31 19 – PROJECT MEETINGS</u>

### Page 1, add new subsection 1.4 as follows:

.1 A pre-construction site visit will be held on Sable Island. Include the cost of attending this

meeting in the Contract price. The Contractor is to allow space for two Owner representatives

for travel to the site. There is to be no overnight stay for this site visit. No extra reimbursements will be made by the Owner to the Contractor for this site visit.

# <u>SECTION 01 35 43 – ENVIRONMENTAL PROCEDURES</u>

### Page 6, add new subsection 1.12 as follows:

1.12 FUELING .1 Fueling equipment on the island must be done at the designated fueling area located at Main Station.

### SECTION 01 74 11 - CLEANING

# Page 2, add new subsection 1.3.3 as follows:

.3 Provide pallets, waste bags and packaging for use in in removing all old equipment and garbage from the project. Place waste material on pallets, wrapped securely and relocate to mainstation for storage.

# <u>SECTION 46 07 00 – PACKAGED WATER TREATMENT SYSTEM</u>

Page 9, delete subsection 2.13 (Fencing).

## Page 10/11, delete subsection 3.3 and replace with the following:

### 3.3 TESTING

- .1 Collect water samples for analysis by an accredited laboratory facility after the completion of the work as follows:
- .1 Raw and Treated Water microbiology: two (2) samples of each (four total) taken not less than 30 minutes apart for total coliforms and e.coli (presence/absence) with the system running but not yet placed online. Once the system is placed online, three (3) additional samples are to be taken at Main Station building locations as directed by the Parks Canada.
- .2 Raw and treated water general chemistry and metals one (1) sample of each (2 total) with the system running and not yet placed online.







,3 All samples are to be submitted to an accredited laboratory within the designated hold times listed by the laboratory for the analytes. All samples are to be analyzed and reports provided within 24-hours of sample submission (24-hour turnaround).

Within the entire drawing package delete all fencing shown and delete all references to fencing within the notes.
