#### **Q 033**

M2/R2 in Work Stream 001 and 002, would the Crown consider altering the references to PeopleSoft and/or SAP [defined in bullet i)] to read “collaboration with the former ERP service provider”?

#### **A 033**

*After review, Canada has decided to keep the RFP the same. M2/R2 in both streams will remain the same.*

#### **Q 034**

Referring to the answers to Question 30 posted in Amendment No 005:

“A 030a)

all qualified TBIPS SA holders are invited to bid on this requirement. This requirement (including resource categories and elements of the Statement of Work) has evolved considerably from past contractors – it is not a direct follow on requirement.

A 030b)

there was no firm or individual performing work related to the systems described for either of the 2 streams in preparation for this new requirement.”

As there are no incumbents and this is “not a direct follow on requirement”, we respectfully request the removal of M2 and R2 in their entirety for both Work Streams.
