Amendment 001 to Solicitation W0114-190001/A – Mechanical Lift

The purpose of this amendment is to provide Canada's response to Bidder's questions and revise some areas of Annex A.

Q1. Do they want to have the posts on the side or are they ok with front and rear? The front and rear option also comes with wheels that they can use to then fit different length vehicles, they still work synchronized.

R1. For this requirement the posts must be on the sides of the vehicles.

Q2. In paragraph 3.4 of the Annex 'A' you mention CSA certification, is that for the motor or for what exactly are they looking for?

R2. Yes, motor must be CSA certified.

Q3. In paragraph 3.9 of the Annex 'A' what safety locks are they talking about? Can you provide some clarification about this whole sentence?

R3. Mechanical safety locks for lifting arms, which must have the capability of being engaged while the lifts are not in operation.

Q4. Paragraph 5.1 of the Annex 'A' states Owner's manual to cover "supply"? What is that supposed to mean?

R4. Manual to cover operation and maintenance only.

Refer: Annex A Requirement, 5.0 Deliverables

Delete: 5.1 Owner's manuals (both English and French) which cover supply, operation and maintenance must be delivered with the equipment.

Insert: 5.1 Owner's manuals (both English and French) which covers operation and maintenance must be delivered with the equipment.

Q5. On paragraph 3.6 of the Annex 'A', you mention 16 extension sockets. Does it have to be 16? Are they just interested in the machine being able to fit under anything and lift just about any vehicle? What is their purpose?

R5. Yes we need 16 extension sockets for the lift arms, so that the lift can accommodate multiple vehicles.

Q6. "provision of two (2) twin-post hoists for vehicle maintenance" Does this mean of standalone provision of product that is to be installed by a separate party or does this require the product to be installed by the awarded supplier? If installation is required, does the client provide power and air hookup?

R6. **Installation is not required from the supplier. It is a standalone provision of the product that will be installed by a separate party.**

Q7. **In paragraph 3.1 of the Annex 'A' must have 2 hydraulically synchronized column with no structural obstruction between posts. Would an electronically synchronized system with no structural obstruction between posts be accepted? This feature adds additional safety to the system.**

R7. **Yes we will accept an electronically synchronized system with no structural obstruction.**

Delete: 3.1 Must have 2 hydraulically synchronized column with no structural obstruction between posts.

Insert: 3.1 Must have 2 hydraulically or electronically synchronized column with no structural obstruction between posts.
