Questions and Answers

20. R.089513.001 REQUIRED SERVICES..... RS 11 Other Services (OS) / Page 21;
Items OS.11.1 to OS.11.10 are noted as (Required/Not required). Clarification required.

- a. The RS 11 Other Services items OS 11.1 through to OS 11.10 are required for this project.

ARCHITECTURAL FIT-UP.....

21. In the current(ongoing) upgrade of the Washrooms, was the infrastructure replaced? If not, is it in this scope of work?

- a. The washroom infrastructure wasn't replaced during the recent washroom upgrade project. Washroom infrastructure replacement is not included in the scope of work.

22. In regards to number of flushes for the new staff count, does PSPC require this Work to meet NBC Requirements or Labour Code – Occupational Health & Safety Regulations?

- a. An evaluation of the number of fixtures required for the new staff count is to be included. Design work to increase the number of fixtures in the existing VanSteenburgh washrooms is not in the scope of work.

23. In the RFP it mentions the upgrade to luminaires to LED efficient lighting. Is it the intent of this Work to maintain the existing ceiling system or replace it as a result of demolition/new construction?

- a. The intention is to maintain the existing ceiling system wherever possible.

24. MECHANICAL..... Pertaining to the energy budget/model, the Project brief does not mention performing one under the mechanical scope, but it does appear in the RS document. Clarification required.

- a. An energy budget and modelling will not be required in the VanSteenburgh scope of work. However, PSPC's expectation is that energy efficiency is a priority in the Consultant design work.

25. The RFP mechanical requirement 1.3.3.2 notes to confirm the suitability of existing Air Handling Units and associated infrastructure, cooling ductwork etc. For the purpose of determine level of effort for the detailed design how are we to treat the possibility that this major equipment may need upgrading, which would be a significant engineering item?
- a. If additional design work is required for major mechanical equipment upgrade the Supply Arrangement will be amended to include the required scope of work.
26. Who is responsible to provide the commissioning agent? And would this be a 3rd party agent in addition to the mechanical/electrical consultants?
- a. For smaller scopes, PSPC does not always provide a Commissioning Manager and as such, commissioning responsibilities will remain with the Consultant for this contract. A 3rd party Commissioning Agent is not required.
27. If there is a 3rd party commissioning agent, would the portion of the mechanical scope 1.3.3.2 be fulfilled by them? (similar for electrical).
- a. A 3rd party Commissioning Agent is not required.
