This amendment is raised to publish questions and answers as follows:

Question and answer

What is the total number of employees and organizations (i.e. departments, agencies and Crown corporations) who would be able to choose to use the social recognition platform?

The eligible institutions are listed in Schedules I, I.1, II, and III, of the Financial Administration Act, R.S., 1985, c. F-11. There is a total of 131 organizations (i.e. departments, separate agencies and Crown corporations) and 414,595 full-time equivalent employees*. This is the maximum number of organizations and employees that are able to choose to use or not to use the social recognition platform. The social recognition platform will be a voluntary tool, similar to the two current Awards Programs. 79 departments and agencies use the current Instant Awards Program.

*Note: Data regarding departments and separate agencies is as of March 31, 2018, while data regarding Crown corporations is as March 2017).
