This amendment is raised to answer the following questions from suppliers.

Q8) Can Canada confirm the method of payment for the resulting contract? Will payment be made only after receipt of product and invoice, net 30 days (i.e.: no advance payment or payment upon ordering?)

A8) Yes, the method of payment for the resulting contract is payment upon acceptance and delivery. There are no advance payments or payment upon ordering for this requirement.

Q9) Can Canada confirm whether the first order is not required until, on, or before Sept 2019? Would DND accept early delivery?

A9) With the exception of the first year of the initial period, each year of the resulting contract begins on 1 April. Each year, DND will accept delivery of that year's supply of firing pellets at any time between 1 April and 15 September. For example, for Year 2, which spans from 1 April 2020 to 31 March 2021, DND will accept delivery of the firing pellets at any time between 1 April 2020 and 15 September 2020 (i.e.: "on or before 15 September 2020"). Bidders should consult Annex "A" – Delivery Schedule and Basis of Payment.

Q10) Is a product sample required with the bid?

A10) No, a product sample is not required with the bid.

Q11) Is the quantity of an annual supply of 13,660 packs of firing pellets, 500 per pack, a firm quantity, or will it be a standing offer or on an "as and when requested" orders?

A11) Yes, the requirement for an annual supply of 13,660 packs of firing pellets, 500 per pack, is a firm quantity. One (1) contract will be awarded as a result of this solicitation process. This requirement is not for a standing offer, nor for a contract where the work is completed on an "as and when requested" basis.
