QUESTIONS / ANSWERS

Question #3:

Please refer to Attachment 4.1, Bid Evaluation Criteria, 1.1 Bidder Mandatory Criteria for Stream “A”, and Bidder Mandatory Criteria for Stream “B”. M2, item #4 (in both streams) states: “The Bidder’s proposed Level 3 Resources must sign a certification that it is only proposed once as a Level 3 Resource in response to this RFP”; and M2, item #5 states: “A resource must not be proposed more than once”.

Could the crown please confirm that item #4 indicates that a Level 3 resources may not be bid in multiple categories or levels in response to this Solicitation?

Furthermore, could the crown please confirm that item #5 indicates that all resources must be exclusively bid by on supplier?

Answer #3:

As per Article 3.2 (Technical Bid) paragraph (IV), it’s stipulated the following:

“The same individual must not be proposed for more than one Resource Category and level / Workstream”.

Item #4 - The Bidder’s proposed Resources must sign a certification that it is only proposed by one supplier in response to this Solicitation.

Item #5 – Yes, confirmed.

Question #4:

Please refer to Attachment 4.1, Bid Evaluation Criteria, 1-2 Bidder Point-Rated Criteria Stream “A”, and Bidder Point-Rated Criteria Stream “B”. The Point Scales at R2 and R3 (for both Streams) are as follows:

Five (5) or six (6) categories – 25 points

Four (4) or five (5) categories – 20 points

Two (2) or three (3) categories – 15 points

One (1) category – 5 points

Based on the breakdown of points as currently written, it isn’t clear how many points will be awarded to a Bidder who provides five (5) resources of the same or similar categories on contract. Please confirm how points would be awarded for 5 categories.

Attachment 4.1, Bid Evaluation Criteria, 1-2 Bidder Point-Rated Criteria Stream “A”, and Bidder Point-Rated Criteria Stream “B”. The Point Scales at R2 and R3 (for both streams) are **NOT** the same.

Please confirm that ‘Project Lead’ was included in error and this should read: “Minimum two (2) years’ experience as a Helpdesk Specialist in a Virtual Desktop environment using VMware Horizon View”.

Question #6:

Please refer to Stream B M1 – Corporate Capacity. The bidder must have performed one IT Operations Services contract. These services must have been provided within the past five years (as of solicitation posting date). The contract identified must:

2. Have an initial minimum value of \$1,000,000 (Cdn) before taxes, not including amendments;

Many Government of Canada contracts are awarded at just below the \$1,000,000 mark due to departmental signing authorities and subsequently amended to values beyond \$1,000,000. Would the crown consider changing this to:

2. Have a minimum total contract value of \$1,000,000 (Cdn) before taxes, including amendments.
