**The purpose of this Solicitation Amendment is to provide a response to questions asked as follows:**

1. As per the tender info, telescopic booms and other snow removal equipment must be removed from site daily. If there are delays with the transport company, can arrangements be made with Public Works for temporary paid parking?

**Response:**

No, PSPC does not have any parking.

2. Tender states an 85ft boom is required. Will a 125ft boom be needed to clear the new fence at Postal Station B, as currently required?

**Response :**

Tender states 85ft is required but this in a minimum requirement only. PSPC will not pay any extra for other Boom truck.

3. Do you know the approximate amount of ice melt required per season and can it be stored onsite?

**Response :**

No, it depends on the amount of snow. And yes we will get a small storage area to put some equipment.

4. When the steam machine is required to be onsite during or in advance of a weather event, can this be kept onsite?

**Response:**

See # 3 above.

5. The tender info specifies 24/7 service is required. What is the expected response time after a call and what is the process for reaching afterhours contacts?

**Response:**

See Section 1, Clause 9 of the Statement of Work.

6. As all staff are required to be SECRET cleared, how long does it take to obtain this clearance?

**Response:**

To be determined by security section, each case is different.
