AMENDMENT 003 IS RAISED TO POST ANSWERS TO ENQUIRIES (Q&As):

Q1: Will the shipping location be able to accommodate a 53 foot trailer for the delivery of the goods? If not, what is the maximum truck length the location can accommodate?

A1: 53ft trunk is not appropriate as we expected that at the time of delivery, the site will still be in construction state. Delivery should be in small trucks unloading either at the CBSA entrance and/or the front entrance.

Q2: Should electrical power feeds (ceiling feed, base feed) be part of our submission? If yes, can you please provide the technical requirements related to the electrical power feeds.

A2: Currently we are showing the receptacles/power connections to the furniture on our drawings. The contractor would just require some sort of chase to get from the wall into the furniture.

Q3: “Can we offer Laminate as an alternative to metal?”

A3: No
